McCollum To Reschedule Cannabis

I recently met with Bill McCollum. According to F.S. 893-0355, the Attorney General has the authority to change the scheduling on a drug if it is 'in the public interest'. We know the evidence for re-scheduling cannabis is overwhelming. It is up to us to convince Mr. McCollum to change the scheduling of cannabis, allowing doctors to recommend it for treatment. I will be meeting with him again soon. His term as Attorney General ends this year and he is running for Governor. Our goal is to convince him to reschedule Cannabis before November 2, 2010.
